- 2. The school shall be opened to inspection by the Officers of S & ME Deptt. as and when required.
- 3. No Financial Assistance or any kind of Grant-in-Aid (either recurring or nonrecurring) will be claimed by the institution from the Government at any point of time.
- 4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same on violation of terms and conditions laid down in Govt. Acts / Rules / Executive Instructions .
- 5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
- 6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
- 7. The land on which the school stands is recorded in the name of the Trust / Society / Agency which manages the School. It will be the responsibility of the School Authority to record the required land (1.00 Ac in Urban / 1.50 Ac. in Rural) in the name of the school and submit copy of the RoR to this Directorate within one year for continuance of NOC.
